The 2010/2011 Somerset Area Ambulance Association membership drive is underway. We would like to take this opportunity to thank all of our current members for your continuing support. We also want to encourage new members to join this needed Association.

Trying to do our part in a tough economy, we have decided not to increase the memberships for the upcoming year. Additionally, we continue to apply for government grants as they become available trying to offset our ever-increasing expenses. Most importantly, your donation helps to insure that this needed service will be there when you call.

We expect little change in our call volume for the upcoming year. We continue to operate a main station on the Lake Road in Somerset and a sub station along Route 30 in Stoystown. Our fleet of 5 ambulances, 2 wheelchair vans, and a paramedic assist unit will be used to respond to our calls during the upcoming year.

Please be aware that additional charges are assessed to all persons (members and non member) who utilize our wheelchair van service. Remember that wheelchair vans are governed by the PUC and fees for that service are in accordance to their regulations. In addition, due to high deductibles, we reserve the right to bill direct to individuals by-passing insurance companies for wheelchair van transports. Also, because of the passage of new PA Dept of Health regulations, we are eliminating our wheelchair van "cot" service. (Any patient requiring a cot for transportation will need to go by ambulance).

While renewing your membership or taking out a new membership could bring substantial savings to you and your family, insurance coverage varies from policy to policy making it somewhat confusing to know how much savings you may receive from a membership. Any question's regarding insurance coverage can be directed to the business office which is open Monday thru Friday from 8 AM to 4 PM.

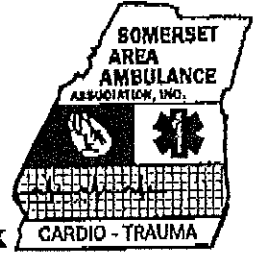
